Limited Warranty



Wilsonart[®] Flooring For Interior Residential Flooring Applications

Effective February 1, 2007

Wilsonart International, Inc. ("Wilsonart") warrants the flooring products listed at right ("Interior Residential Flooring Products") to the original consumer purchaser, under normal use and service, against the stated warranty coverages and for the stated warranty periods. This warranty is extended for the specified period after the date of purchase by the original consumer purchaser and only is extended to, and may only be enforced by, that person. THIS WARRANTY IS NOT TRANSFERABLE. This warranty only applies to an Interior Residential Flooring Product which has been installed in a residential interior application and remains installed at that original residential installation location. This warranty is expressly conditioned upon submission of proof of date of purchase.

EXCLUSIONS:

Wilsonart[®] Flooring is a laminate and wood product, and therefore, seasonal changes may result in expansion and contraction to individual planks/tiles, causing minor separation to occur; this is not a defect in the product and is not covered by this warranty.

*DEFINITIONS:

• To be covered, "Wear" must be through the decorative print. Gloss reduction is not wear.

• To be covered, "Fade" must be due to exposure to sun or electrical light.

 "Topical Water Damage" means that the planks or tiles will not swell, delaminate or peak at the seams due to topical spills, provided water is promptly removed and the floor is allowed to dry.

 "Lifetime" means the lifetime of the original consumer purchaser who resides in the residence in which the product is originally installed. This warranty shall not apply to damage arising from any of the following:

- accidents, abuse or misuse;
- exposure to extreme temperatures or extreme relative humidity;
- failure to install or use the flooring product in accordance with Wilsonart Flooring Installation Instructions;
- improper maintenance;
- improper adhesive;
- excessive moisture or flooding, either by natural causes, plumbing failures, leaks from household appliances, mechanical failures, or urine; and
- trapped water underneath the floor arising out of or in connection with any condition of the sub-floor or improper pad.

This warranty shall be void and of no further force or effect if any of the following events occur:

- the product is removed from the original place of installation;
- sale of the home where the product was originally installed; and
- unauthorized repairs to the product.

WHAT WILSONART WILL DO:

If an Interior Residential Flooring Product is found not to have performed as warranted during the specified warranty period:

<u>For warranty claims made during the first year after date of purchase:</u> If the Interior Residential Flooring Product was installed by a professional installer, Wilsonart will pay the reasonable material and labor costs to repair or replace, at its option, the warranted product. If the Interior Residential Flooring Product was not installed by a professional installer, Wilsonart will provide material for the repair or replacement, at its option, of the warranted product and no labor costs will be paid.

For warranty claims made after the first year of purchase and up to 25 years after date of purchase: If the Interior Residential Flooring Product was installed by a professional installer, Wilsonart will pay a percentage of the reasonable material and labor costs for repair or replacement, at its option, of the warranted product. This percentage will be based on the number of years from the date of purchase and the remaining warranty period for the particular product, up to 25 years after date of purchase. For example, Wilsonart will pay 20/25 or 80% of the reasonable material and labor costs on an approved claim submitted 5 years after the date of purchase of a product, such as Estate Plus, which is covered for a Lifetime period. If a claim is made with respect to Classic, which has a 20 year warranty, in the 10th year after the date of purchase, Wilsonart will pay 50% of the reasonable material and labor costs. If the Residential Interior Flooring Product was not installed by a professional installer, Wilsonart will pay a percentage of the reasonable material costs only for the repair or replacement, at its option, of the warranted product. As described above, this percentage will be based on the number of years from the date of purchase and the remaining warranty for the particular product, up to 25 years after date of purchase, but no labor costs will be paid or included in the percentage calculation.

For warranty claims on products covered for a Lifetime period made after 25 years after date of purchase: Wilsonart will provide a 5% discount on material only on the original consumer purchaser's next purchase of a Wilsonart Interior Residential Flooring Product. Thus, the original consumer purchaser of Estate Plus, which has a Lifetime warranty period, who makes a claim 30 years after date of purchase, would be entitled to a 5% discount on material only on said purchaser's next purchase of a Wilsonart Interior Residential Flooring Product.

No repair or replacement under this warranty shall extend the warranty period.

Any repair or replacement under this warranty is limited to repair or replacement with colors and styles of products available at the time of repair or replacement. If the original design is no longer available, Wilsonart has the right to substitute another Wilsonart design of equal or less value than the original flooring, and the warranty claim will be calculated and paid on the basis set forth above.

WHAT YOU NEED TO DO:

To make a claim under this warranty, the original consumer purchaser shall contact the retailer from which the flooring product was purchased. All warranty claims will be processed through this retailer. The original consumer purchaser must provide proof of date of purchase. The return of a warranty registration card is not required for warranty coverage and is not proof of purchase.

THE FOREGOING SHALL CONSTITUTE THE EXCLUSIVE REMEDY OF THE PURCHASER AND THE EXCLUSIVE LIABILITY OF WILSONART.

THE ABOVE WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESS WARRANTIES WHETHER ORAL OR WRITTEN. ANY IMPLIED WARRANTIES WHICH MAY ARISE BY OPERATION OF LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO THE PERIOD OF THE WRITTEN WARRANTY SET FORTH HEREIN.

WILSONART SHALL NOT, UNDER ANY CIRCUMSTANCES OR UNDER ANY LEGAL THEORY, BE LIABLE TO THE PURCHASER OR ANY OTHER PERSON FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE, INCLUDING WITHOUT LIMITATION DAMAGES TO, OR LOSS OF USE OF, PROPERTY, DAMAGES FOR LOSS OF PROFITS OR REVENUES OR ANY OTHER DAMAGES ARISING FROM THE ORIGINAL CONSUMER'S PURCHASE. WILSONART'S LIABILITY WILL IN NO EVENT EXCEED THE PURCHASE PRICE OF THE PRODUCT.

Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations and exclusions may not apply to you.

This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

No agent, dealer, employee or representative of Wilsonart nor any installer, fabricator or other person is authorized to modify this warranty in any respect.

The invalidity of all or a part of any of the provisions of this Limited Warranty shall not affect or invalidate any other provision of this Limited Warranty.
